School classification for the regularization of the Recruitment of Academic Staffs to Schools and Placing and Transferring

The circular No.2005/1 dated 18.01.2005 issued by the Secretary of Education with the heading of 'Facility Based School classification for the necessity of implementing the provisions laid down by the Sri Lanka Teachers' Service Minute and National Teachers Transferring policy' and the circular No.2006/43 dated 24.11.2006 issued by the Secretary of Education with the heading of 'Classification of Schools as difficult and very difficult in order to grant a financial Incentive allowance in order to intensify the deployment of teachers to settle the teacher shortages of schools established at the difficult and very difficult areas' are hereby cancelled and subsequently, provisions laid down by this circular shall be effective from today onwards.

- 2.0 Classification of the schools to pay the incentive allowances for principals and teachers on behalf of Serving at the difficult and very difficult as per the Circular No.2006/44 dated 27.11.2006 of the Secretary to the Ministry of Education and to implement National Teacher Transfer Policy as per the Circular No.2007/20 dated 13.12.2007 of the Secretary to the Ministry of Education must be carried out in terms of the provisions laid down by this circular with effect from 05.02.2024
- 3.0 This circular is issued to maintain the school system actively by being processed the learning teaching process without any restriction by being remained the teachers after fulfilling the teachers' shortage with an objective of facilitating the equitable approaches in education and the opportunities of quality in education to the children in difficult areas by considering the differences being prevailed at the provincial levels in infrastructure facilities regionally, geographically and economically.
- 4.0 Schools must be classified as follows by considering the easement of placing the various physical resources and academic staff available in schools.
 - Very difficult Schools
 - ii. Difficult schools
 - iii. Convenient schools
 - iv. Very Convenient schools

5.0 Awarding marks according to the criteria on School Classifications

5.1 The criteria that should be followed and the marks being given are mentioned in the following Table No.01 when marks are given to the schools at the Zonal/Provincial level under the classification of schools.

6.0 Classification of Schools

- 6.1 Identifying the criteria relevant to the significance of the province
- 6.1.1 A committee consisting with seven members should be appointed with the chairmanship of the Provincial Director of Education by the Provincial Secretary of Education to identify the criteria relevant to the significance of their province and the composition of that committee should be as follows.
 - i. Provincial Director of Education. (The Chairman)
 - ii. A representative appointed by the Provincial Secretary of Education
- iii. Deputy/ Assistant Director of Education who is in charge of the Planning Subject under the Provincial Department of Education.
- iv. Two Zonal Directors of Education.
- v. Two Divisional Deputy/Assistant Directors of Education
- 6.1.2 No Divisional Directors of Education under the divisions of the purview of Zonal Directors of Education who have already been performing as the members of the committee should be appointed as the members of the said committee.
- 6.1.3 Actions should be measured by the provincial committee aforesaid in order identify 4-7 number of criteria signified to their own province relevant to the No.06 of the Table No.1 as to be

shown the difficulty of schools belonged to their province precisely in addition to the criteria which are considered at the National Level for the classification of the schools. Accordingly, necessary actions should be taken by the Provincial Director of Education to obtain the approval by secretary to the Ministry of Education after being presented those criteria identified as appropriate by the provincial committee. Marks should be granted according to table No. 01 in section 5.1 followed by obtaining the approval as aforesaid.

6.2 Granting Marks for Schools

- 6.2.1 Actions should be taken by the Zonal Director of Education to grant the marks as follows for the all schools belonged to their own zonal area by utilising the criteria mentioned in the above table No. 01 in section 5.1 and the criteria approved by the Secretary to the Ministry of Education after being presented by the committee of their own province with the assistance of the Deputy/Assistant Director of Education who is in charge of planning subject of their own zonal area and the relevant Divisional Director of Education.
 - i. Total number of marks should be calculated for each school after granting the marks according to the criteria relevant to the school classification for each and every school belonged to their own Zonal area.
 - ii. All the schools under the zone should be prepared in descending order (from highest number to lowest number) in terms of the total marks of the each school after being entered the marks granted for each school under the each criteria in respect of all schools in the zone, in to the specimen Annexure 01 and those school documents must be presented to the Provincial Level Committee mentioned in above Section 6.1.1
 - iii. A certification should be given by the Provincial Level Committee as to be ensured that marks have been granted accurately after being inspected the school documents in all the zones in their own province.
 - iv. Marks granted relevant to the each criteria for all the schools in their own province and the total marks should be entered in to the Specimen in Annexure 1 by the Provincial Directors of Education and those school documents must be presented to secretary to the Ministry of Education with the recommendations of the Provincial Level Committee and the Provincial Secretary of Education.

6.3 Deciding the cut off marks for each category of school.

- 6.3.1 Deciding the minimum cut off mark which decides the each category of school followed by analyzing the marks of the all schools in the island, should be carried out by a committee appointed by secretary to the Ministry of Education.
- 6.3.2 School documents by which schools are classified as Very Difficult Schools, Difficult Schools, convenient Schools and very convenient Schools for each province in terms of the said cut off marks shall be published by the Secretary to the Ministry of Education. Necessary actions are taken to update this school document once in every 03 years.

6.4 Time Frame

6.4.1 Actions should be measured to fulfill the activity of preparing the school document and publication of the same within the period of time as mentioned in the table below.
