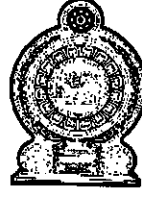

Implementing Curriculum for Secondary Grades (6-11)

From here onwards this amended circular also will be effected, in addition to the circular No 2006/09, released on 07.03.2006, circular No 2007/06, released on 07.03.2006, circular No 2008/12, released on 21.04.2008 and the circular No 2008/12 (1), released on 15.09.2008.

Bilingual Education Programmes implemented in Secondary Grades (6-11)

In relation to the Bilingual Education Programme your attention is focused on instructions mentioned in circular No.2008/12 and 2008/12(1) and you are informed to implement, following instructions also.

2. According to the paragraph 4.3, in the circular 2008/12, to learn selected subjects in English Medium, students should be selected from grade 6. It is not allowed to use the bimedium class, as a privilege for the admission of students to any school.

3. Students for the Bilingual Education Programme, should be selected from the students who are in Grade 6 including the students who enter the Grade 6 class as scholarship bearers as directed by the Ministry of Education. Students who have obtained low marks than the cut off mark of the scholarship exam, which is decided to the relevant school and the students who did not sit for the examination, should not be admitted to the school as Bilingual students, by conducting a competitive examination or not.
4. Students, who are not learning in bilingual education, should not be admitted to the Grade 7 in the school as bilingual students. Even students, who learn in Bilingual education program, are allowed to admit class, only if they change the residence to the relevant Grama Niladhari Division of the school, because of the transfers of the parents or the private matter.
5. Provincial and Zonal level Directors should take the responsibility , to monitor, whether the instructions in this circular and other circulars connected to this matter, are implemented in the schools and when it is not, to take appropriate actions accordingly , with the support of the provincial and zonal level bilingual education coordinators .
