Provision of Financial Allocations for the Accelerated Programme of Development of Physical Resources in Primary Education Sections, Aimed at Enhancing Learning Competencies of Primary Students of National Schools, Excluding Schools Coming under the 1000 Secondary Schools Development Project – 2014/2015

Various quality development programmes are being implemented to develop the child-friendliness of the primary schools and the primary sections of secondary schools in the island. Provision of basic infra-structure facilities to schools is essential in this context. Therefore, measures have been taken to provide grants to develop the physical resources in primary sections and to implement special projects in connection with creating a pleasant learning environment for students with the objective of enhancing the learning competencies of primary students in National Schools. This grant must be utilized solely for the implementation of projects identified at school level on priority basis for developing primary sections of National Schools, excluding schools coming under the 1000 Secondary Schools Development Project.

02 Accordingly, a sum of Rs.600000.00 will be credited into the School Development account of the relevant schools as an outright grant by the Ministry of Education under this programme. The tasks to be completed under this grant must conform to the Circular No. 07/2013 dated 13.11.2013 issued by the Ministry of Education, and the instructions, guidelines and provisions given in the guidebook and the special guidelines given in the code of instructions enclosed herewith.

03 All activities implemented through this grant must be completed by 31.03.2015, and the relevant progress reports must be submitted.

04 Please be informed that to ensure maximum productivity of this accelerated programme, maximum contributions of the relevant Principals must be ensured. Moreover, all PSE's/PDE's/ZDE's must make their contributions by providing guidance to the Principals. The responsibility of implementing this programme falls on the Provincial Directors of Education while the Zonal Directors of Education are responsible for monitoring the programme and maintaining records.

05 I highly appreciate your cooperation in making this programme a success.
