02. Method of Selection:

- I. As per the paragraph 11 of the Service Minute of the Sri Lanka Teacher Educators' Service published in the Extraordinary Gazette No. 1925/37 dated 28.07.2015 of the Democratic Socialist Republic of Sri Lanka, the applications for the above posts are called from the eligible officers, and the appointments to the posts are done by the Education Service Committee of the Public Service Commission considering the preference of the applicant and the recommendation of the Secretary to the Ministry of Education on the basis of the marks obtained by the candidates in a structured interview conducted by a panel of interviewers appointed by the Education Service Commission.
- II. As per the Schedule V of the Service Minute of the Sri Lanka Teacher Educators' Service, only the officers who obtain the minimum pass mark of 35 or more at the structured interview will be selected for the appointment to the relevant posts.
- III. The method of awarding marks for the structured interview has been given in the schedule II of this notification.

IV. The service stations and the posts desired to be applied should be mentioned under the paragraph 08 of the application according to the order of preference. If you do not get qualified to be appointed to an applied post by the merit order, giving appointment to another service station on the service requirement can be considered.

V. Awarding a post on the basis of merit obtained in this interview will be considered only for this stage.

VI. Though the posts have been separated as Sinhala and Tamil medium for administration purpose, any officers who have the ability to serve in the relevant medium can apply for the vacancies.

VII. If an applicant is revealed not to have the required qualification or if any particular furnished by an applicant is found to be false after the selection or if any wrong fact has been deliberately suppressed by him/her, he or she is liable to be dismissed from the post.

03. Qualifications:

I. A Grade I officer who has passed 03rd Efficiency Bar Examination of the Sri Lanka Teacher Educators' Service.

II. An officer who has not been subjected to any disciplinary punishment as per the Public Service Commission Circular No. 1/2020 and has completed an active and satisfactory service period of 05 years.

III. All the qualifications should have been completed on or before the closing date of applications.

04. The relevant structured interview will be held at the Ministry of Education, Isurupaya, Battaramulla. The date of the interview will be notified later. The determination of the Education Service Committee of the Public Service Commission on making appointments to these posts will be the final decision.

05. In the event of any inconsistency among the Sinhala, Tamil and English language texts of this notification, the Sinhala text shall prevail.

Maximum 50 Marks

The marks are awarded as follows for each active and satisfactory year of the Grade 2-II, 2-I and Class I as per the old Service Minute No. 1070/13 dated 11.03.1999 and Class I as per the new Service Minute No. 1925/37 dated 28.07.2015 of the Sri Lanka Teacher Educators' Service (The total marks entitled for an year is awarded for a service period of 12 months and the marks are not awarded for a period less than that)

 - 03 Marks

 III. Class I / Grade I
 - 05 Marks

(When awarding marks for the period of service after the absorption to Grade II, the marks are awarded in relation to the Grade of Class 2 held by the officer at the time of absorption)
