01	5.2	Where a trained teacher obtains the degree, a graduate teacher the Postgraduate Diploma in Education, a trained teacher the Bachelor's degree in Education within seven (07) years of Grade 2-II or where a teacher with degree, Postgraduate Diploma in Education or Bachelor's degree in Education within five (05) years of Grade 2-II on 01.07.2008 or thereafter, he should be placed in salary step prescribed in Schedule I of Public Administration Circular No. 06/2006(XII) from the date he so qualified or under provisions of Section 9 of Chapter VII of the Establishments Code at the time he exceeded the prescribed salary step.

03	5.1.1.2 Note 3	Trained teachers recruited to Grade 3-I (b) of the Service: These teachers will be placed in the third (03) salary step of the Salary Scale of Grade 2-II at the time they are appointed to Grade 2-II after obtaining degree or Bachelor of Education Qualification.
04	5.1.1.2 Note 4	Graduate teachers recruited to Grade 3-I (a) of the Service without pedagogical training:  These teachers will be placed in the fifth (05) salary step of the Salary Scale of Grade 2-II at the time they are appointed to Grade 2-II after obtaining Postgraduate Diploma in Education or Bachelor's degree in Education and Postgraduate degree in Education.
05	7.2.6.2	Appointment to Grade 2-II from Grade 3-II of the Service:  (1) Promotion will be made if the qualifications required for promotion referred to in 13.8 of the Service Minute as per (1) of 7.2.2.1 (e) above are obtained.
06	7.2.6.4	Appointment of teachers recruited to Grade 3-I (c) of the Service to Grade 2-II:  (1) Promotion will be made to Grade 2-II if the qualifications required for promotion to Grade 2-II referred to in 13.8 of the Service Minute as per (1) of 7.2.2.1 (e) above are obtained.
07	7.2.6.6	Appointment to Grade 2-II from Grade 3-I (a) of the Service:  (1) Promotion will be made to Grade 2-II when the qualification of Postgraduate Diploma in Education is obtained.
08	10.5	Promotions made to Class 1 based on the period of service of five (05) years or the promotions made on method of awarding marks for untrained period of service or under any other provisions during the period from 01.07.2008 to 31.12.2010 under the previous Service Minute should not be amended under the provisions of new Service Minute.
09	10.2.1.1. (iii)	Should have shown a satisfactory or higher level of performance during three (03) years immediately proceeding to the date of promotion as per approved procedure of performance appraisal including the professional review.
10	10.3.2	Promotion of teachers in Grade 2-II with training in teaching and degree qualification as at the effective date and trained teachers obtaining degree qualification during seven (07) years of Grade 2-II after the effective date to Grade 2-I.
